THE DECISION

(1) That the Cabinet member approves a procurement process, to be undertaken jointly with West Sussex County Council, to establish a new framework of approved and preferred independent providers of children's residential and foster care services when the current framework ends. The term of the new Framework contract shall not exceed four years;

(2) That the Cabinet Member authorises the Strategic Director, People to approve the award of a Framework agreement to selected providers following completion of the procurement process.

REASON FOR THE DECISION

- (1) Required by Section 22G of the Children Act 1989; and
- (2) in order to ensure that the principles and timescales of the EU Public Procurement directives are adhered to the tender process for any new arrangements must start by February 2012

DETAILS OF ANY ALTERNATIVE OPTIONS

- (1) An alternative to procuring placements from a framework of approved providers would be to procuring placements predominantly on a spot purchase basis. This would contravene BHCC's procurement standing orders and the principles of the EU Public Procurement Directives. Further, this method of procurement does not promote high quality, value for money services;
- (2) BHCC could establish a framework independently of any other local authority but (national) research and good practice guidance highlights and added financial and quality benefits that are achieved from sub regional or regional commissioning. Working collaboratively with other local authorities ensures more effective market development and cost control. The Sufficiency Guidance urges local authorities to commission services jointly where this will

have a positive impact on sufficiency;

- (3) Block contracts could be established with identified providers. This involves purchasing a specific (minimum) number of placements with individual providers for the duration of the contract.;
- (4) This would limit choice in relation to fostering services and similar benefits can be obtained by the local authority with cost and volume arrangements (on a sub regional basis). The focus on increasing the percentage of children placed with in-house foster carers is the current strategic commissioning priority for BHCC;
- (5) There is evidence to suggest that timely development of local high quality residential placements may be assisted by tendering on a block contract basis. However, the central tenet of IPT is that the individual needs of the child are identified and the most suitable, available placement identified. Placement choice should not be limited by the pre-purchase of placements in specific homes.;
- (6) Collaboration with other local authorities is often the most appropriate way of block contracting with providers particularly in relation to low incidence specialised services. Further discussions need to take place with WSCC, ESCC and interested providers to evaluate the relative benefits of such a mode; and
- (7) The framework contract will be let in such a way to ensure that the potential to commission placements via block contracts, if the local authority so wishes, remains an option.
