# 1. SUMMARY AND POLICY CONTEXT:

- 1.1 The Sussex Rehabilitation Centre (SRCS) provides rehabilitation for conditions including strokes and Acquired Brian Injuries. The centre is currently based at Southlands Hospital in Shoreham and is used by patients from across Sussex.
- 1.2 Worthing and Southlands Hospital Trust (WASH), which owns the Southlands site, is planning to reconfigure some services at Southlands, and local NHS Trusts have accordingly agreed to relocate some services currently based at the hospital, including elements of the SRCS.
- 1.3 For Brighton & Hove patients, this will mean the current rehabilitation services being temporarily re-provided at the Princess Royal Hospital (PRH), Hayward's Heath. This will enable SRCS services to be co-located with the Hurstwood Park neuro-sciences unit.
- 1.4 In the longer term, Brighton & Sussex University Hospitals Trust (BSUHT) plans to re-locate its neuro-sciences department from Hurstwood Park to the Royal Sussex County Hospital (RSCH) site in Brighton in order to create a regional trauma care centre. This move will necessitate the permanent relocation of SRCS services for Brighton & Hove residents. The permanent home for these services has not yet been determined.
- 1.5 This is not a new initiative; the Health Overview & Scrutiny Committee (HOSC) has already agreed plans to relocate these services. Rather, this is

an update on progress towards achieving the agreed goal of temporarily relocating SRCS services for Brighton & Hove residents at PRH.

The eventual relocation of neuro-sciences at RSCH will mean that Brighton & Hove residents suffering major trauma will be able to access local services rather than being treated in London hospitals (although the numbers involved are likely to be very small).
