#### 3. (i) Remove cycling ban on Hove Promenade

To receive the following e-Petition presented at Council on 22 March 2012 by Mr Turnbull and signed by 159 people:

"We the undersigned petition the Council to remove the ban on cycling on Hove promenade between the Peace Statue to the end of Hove Lawns".

#### 3. (ii) Parking Restrictions in The Droveway, Hove

To receive the following paper petition presented to Council on 26 January 2012 and signed by 91 people:

"A petition to Brighton & Hove City Council to introduce parking restrictions in The Droveway, Hove from residents, businesses and parents of schoolchildren".

# 3. (iii) Brighton & Hove Albion football supporters inconsiderate parking in the East Moulsecoomb area

#### 3. (iv) Call to assess Cable Car from motorways to seafront

"We the undersigned petition the council to take the initiative and encourage private investment into innovative private projects in Brighton and Hove, at no cost to the council or tax payers, to promote business and employment locally.

We ask the council to invite feasibility studies for a new cable car service to take visitors from the motorways directly to the seafront to stop adding to congestion and air pollution in Lewes Road and London Road and other parts of our city."

#### 3. (v) Loading restrictions on Western Road

To receive the following paper petition submitted by Mr Adam Campbell and signed by 263 people:

"We the undersigned (local traders and residents of parking area M), object in the strongest possible terms to the proposed introduction of loading restrictions on the North side of Western Road between Holland Road and Farm Road. We would ask you to consider the damage these restrictions will have upon local independent businesses and the residents that depend upon them."
