1. SUMMARY AND POLICY CONTEXT:

1.1 The report asks Cabinet to note the amendment made to the boundary of the area covered by the previously agreed article 4 direction to remove permitted development rights for changes of use from dwellinghouses (use class C3) to small Houses in Multiple Occupation (use class C4). The amended boundary excludes land within the South Downs National Park and is shown on the map in Appendix 1.

2. RECOMMENDATIONS:

2.1 That the Cabinet notes the amendment to the boundary of the area to be covered by the article 4 direction agreed at the Cabinet meeting on 15 March 2012. The amendment excludes land within the South Downs National Park.

3. RELEVANT BACKGROUND INFORMATION/CHRONOLOGY OF KEY EVENTS:

- 3.1 At the Cabinet meeting on 15 March 2012 it was agreed to make an article 4 direction to remove permitted development rights for changes of use from a dwellinghouse (use class C3) to a small House in Multiple Occupation (use class C4). The article 4 direction was proposed to cover five wards within the city. These wards are Hanover and Elm Grove, Hollingdean and Stanmer, Moulsecoomb and Bevendean, Queen's Park and St Peter's and North Laine.
- 3.2 Parts of Moulsecoomb and Bevendean and Hollingdean and Stanmer electoral wards lie within the South Downs National Park ("the SDNP"). The South Downs National Park Authority is the Local Planning Authority for those areas. Brighton and Hove City Council does not have powers under planning legislation to make an article 4 direction on land within the National Park and, accordingly, the plan to be attached to the Article 4 Direction must exclude land within the SDNP.

- 3.3 The National Park's Core Strategy will be the document setting out planning policy for the parts of those two wards that lie within the National Park. Any policy on Houses in Multiple Occupation within Brighton and Hove City Council's forthcoming City Plan would not cover land within the National Park.
- 3.4 Since the National Park was set up, Brighton and Hove City Council had an agency arrangement under which we have determined planning applications on behalf of the National Park Authority. It has been agreed that this arrangement will cease in the near future.
- 3.5 The public consultation authorised by Cabinet is about to commence and it was therefore considered expedient to use the Council's urgency procedure to allow the Head of Planning and Public Protection to authorise the amendment to the plan, following consultation with the Leader, to enable the consultation to proceed. The plan has now been redrawn with the effect that the article 4 direction area covers the five wards as previously agreed, but excludes the National Park land within Hollingdean and Stanmer and Moulsecoomb and Bevendean wards.
- 3.6 This change would have little or no impact upon the effectiveness of the article 4 direction. There are few dwellings within this part of the National Park (primarily those within Stanmer Village).

4. COMMUNITY ENGAGEMENT AND CONSULTATION

4.1 Public consultation will be carried out in accordance with the legislation as set out in the Cabinet report of 15 March 2012.

Legal Implications:

- 5.2 Article 4 of the Town and Country Planning (General Permitted Development)
 Order 1995 (as amended) allows local planning authorities to make Directions
 withdrawing permitted development rights where the authority considers it
 expedient that development should not be carried out unless express planning
 permission has been obtained for the same. Insofar as the Council is not the
 local planning authority for land within the SDNP, and is not authorised to act as
 agent on behalf of the South Downs National Park Authority in connection with
 Article 4 Directions, the Direction, the subject of this Report, must be amended to
 exclude land within the SDNP area.
- 5.3 Part A 7.2 paragraph 7(2) of the Constitution provides an urgency procedure for officer authorisation where it is not reasonably practicable to obtain Member approval prior to a decision being made. Any action taken using the urgency procedure must be reported to the appropriate Member Meeting.
