13. PETITION - BRIGHTON LIBRARY: BIOGRAPHY SECTION

13.1 The Sub-Committee considered a petition presented by Councillor Taylor at Council on 21 July 2005 (152 signatures) as follows:

"We, as readers who borrow books from Brighton Library, call upon the council to restore, as a matter of urgency, 920 Biography section so that we can readily find accounts of inspiring, empowering and entertaining lives in all their variety."

14. PETITION - BRIGHTON LIBRARY: CRIME FICTION SECTION

14.1 The Sub-Committee considered a petition presented by Councillor Paskins at Council on 21 July 2005 (140 signatures) as follows:

"We urge that the council brings back the Crime Fiction section at Brighton Library so that we can easily find such books, and in the process, discover other authors of such an ilk. We also ask that the council conduct an investigation of its own into the circumstances surrounding the mysterious disappearance of a popular section."

15. LIBRARY SERVICE STOCK ARRANGEMENT

19. RENAISSANCE IN THE REGIONS UPDATE

- 19.1 The Sub-Committee considered a report of the Director of Cultural Services concerning the Museums, Libraries and Archives Council's (MLA) scheme for the development of regional museums services, Renaissance in the Regions (see minute book).
- 19.2 Members noted the liaison taking place between Children, Families and Schools and the Museums Service to address the needs of local schools. It was suggested that members of the Sub-Committee be invited to make a visit to view some of the activities taking place.

- 19.3 Members hoped for rapid progress in the development of the Courthouse as a multi-purpose community learning/lecture space. They were advised that, while funding had been secured, planning consent was still being considered by GOSE.
- 19.4 The Director advised the Sub-Committee that the Chair, Councillor John, has been appointed to the Museums Association council for a three-year period.
- 19.5 **RESOLVED** That the information in the report about the Renaissance in the Regions scheme be noted.
- 20. AMENDMENTS TO SERVICE, AND ADMISSION TARIFFIS IN THE ROYAL PAVILION, LIBRARIES AND MUSEUMS DIVISION

- 20.1 The Sub-Committee considered a report of the Director of Cultural Services setting out proposed changes to service and admission charges in the Royal Pavilion, Libraries and Museums Division where these vary from the rate of inflation (see minute book). Officers explained that the recommended changes were based on comparison with the cost of similar services and admissions in other areas and the need for the council to cover costs.
- 20.2 The report also advised on the introduction of an audio guide system in the Royal Pavilion.

RESOLVED – (1) That the changes to service/admission tariffs where these vary from the rate of inflation, as listed in Appendix A, be approved.
