21 PROCEDURAL BUSINESS

21A Declarations of Substitutes

21.1 There were no declarations of substitutes.

22. MINUTES

24. PUBLIC QUESTIONS

24.1 No public questions were asked.

25. FOREIGN LITERATURE IN THE JUBILEE STREET LIBRARY – LETTER FROM COUNCILLOR ALLEN

25.1 Councillor Allen attended to speak in support of a letter he had submitted proposing that the Jubilee Library increase its stock of foreign literature (see minute book). He considered that there was a need to replenish current stock with more works by major writers in the original languages.

25.3 **RESOLVED** – To note the letter from Councillor Allen and the response.

26. TWELVE – PRESENTATION BY THE KEEPR OF WORLD ART

26.1 The Keeper of World Art and the Curator of World Art made a presentation on Project Twelve, which had involved collaboration between Brighton Museum & Art Gallery, the artist Erika Tan and individuals from Brighton & Hove Chinese communities. The project had enabled them to compile an archive of images and oral testimonies relating to Chinese history in Brighton & Hove. New installations and displays had been set up in Brighton Museum & Art Gallery. The officers stated that they that they hoped to adopt the model for work with other communities in the city.

27. ARTS COMMISSION 'MAKING A DIFFERENCE PROGRAMME'

27.1 The Sub-Committee considered a report of the Director of Cultural Services concerning the latest activities of the Arts Commission of Brighton & Hove including the lottery funded programme *making a difference* (see minute book).

28. PROGRESS ON BRIGHTON & HOVE'S SPORTS STRATEGY

28.1 The Sub-Committee considered a report of the Director of Environment concerning the Sports Strategy for Brighton & Hove (see

minute book). The Sports Strategy and Action Plan will be submitted to the Policy & Resources Committee on 25 January 2006 for adoption, following formal consultation. The Head of Leisure stated that the aim was to encourage more residents to become involved in sport and take exercise. She invited Sub-Committee members to give their views.

28.2 Members made the following points:

- Children should be encouraged to exercise outside school hours. Experience has shown this works better when they are consulted on the resources they need.
- Schools have good facilities which should be used out of hours.
- People need to be aware of the options available for exercising for 30 minutes 5-times a week.
- We need a strategy to reconcile the use of playing fields by different sports clubs.

30. NEW ROAD ENVIRONMENTAL ENHANCEMENT

- The “no right turn” sign for traffic leaving New Road must be enforced;
- The council should be prepared to close New Road for events during the Festival and at other times;
- Disabled parking;
- Re-location of the Max Miller statue.

32.1 The Sub-Committee considered a report of the Director of Strategy & Governance informing members on awards received in respect of the Jubilee Library and on the Word project, which is being used to celebrate the opening of the library and to promote reading. The report also provided the results of a recent Economic Impact Study undertaken for the wider Jubilee Street redevelopment process (see minute book).

APPENDIX**Foreign language collections in Jubilee Library****Response from Cllr Sue John to Cllr Kevin Allen**

We are pleased that Councillor Allen appreciates the extensive and representative collection of foreign literature in translation held at Jubilee library. Works by many foreign writers in translation were amongst the 25,000 new books bought for the opening of the new library.

The collection of literature in translation is more limited but has also been refreshed and added to. The budget allocation from the bookfund for this section was increased in 2004/5 and again in 2005/6. Last year the library service bought new collections of the major European languages (French, German, Spanish and Italian) for Jubilee and for Hove libraries. We also have new titles in Italian and Russian, plus a few examples of other languages.

The purchase for the collections focussed more on best-selling books in these languages in order to maximise issues and use of the collections rather than especially buying the classics.

The library still has around £3000 from this year's allocation to spend on books in other languages. The plan was to spend it again on titles in the 4 major European languages, plus a small collection in Polish, because of the increase in Polish workers to Brighton & Hove. However these plans could include the addition of a wide-ranging selection of classics.

There is always the facility for the library service to request batches of 6 books at a time in particular languages through the inter-library loans scheme. This could be used to cover the classics in the meantime. In addition local university libraries also provide reference access to a significant collection of literary classics in their original languages.

The library service also liaises with relevant community groups to assess needs and could promote its collections more via publicity and information on its website.
