23 MINUTES

24 CHAIR'S COMMUNICATIONS

24.1 The Chair and Sub-Committee sent their very best wishes to Tony Miller, Director of Cultural Services, who remains unwell. The Acting-Director explained the interim arrangements for covering his responsibilities.

25 PUBLIC QUESTIONS

25.1 Mr Christopher Hawtree asked: "Could Councillor John please tell us the status accorded this Committee in the hierarchy of the Committee system?" The Chair replied: "The Culture & Tourism Sub-Committee is a sub-committee of the Policy & Resources Committee. Having delegated functions of the Council in relation to:

(1) Culture, arts and heritage and without prejudice to the generality of the foregoing, to exercise the Council's functions in respect of arts, entertainments and cultural activity;

(2) Tourism, Marketing, Libraries and Museums, including conferences, art galleries, historic buildings and their gardens and the functions of the council regarding public records;

(3) To act as the consultee on major events and future policy, in line with the Tourism Strategy."

25.2 Mr Hawtree asked a supplementary question referring to the number of reports on the agenda which are "for noting". The Chair replied that all Sub-Committee members make regular input to the Culture and Tourism strategies and action plans, for example, the Libraries Plan, item 29 on the agenda.

26 BRIGHTON DOME & FESTIVAL LTD

26.1 Nick Dodds, Chief Executive, and Pippa Smith, Head of Education Unit, Brighton Dome & Festival Ltd, made a presentation focussing on the company's education work for people of all ages.

27 PETITIONS

27.1 The Sub-Committee noted the following 223 signature petition presented by Councillor Tonks to council on 7 December 2007

"We, the undersigned readers, call upon Brighton & Hove City Council to increase the book stock in all its libraries as matter of urgency in a city avid for reading in all its diversity."

The Chair replied that Brighton & Hove Libraries has the sixth largest book stock collection and the third highest number of reference books of all 46 Unitary authorities. In 2004-5 the council exceeded the Public Library Standard for number of items added to stock as a result of the pump priming for Jubilee Library, and is striving to achieve the

standard again this year. The council has negotiated high levels of discounts for its book purchases and has achieved around £120,000 worth of additional buying power as a result. Any further increase in numbers of books bought would require an increase in book fund which is not currently possible within existing Libraries resources.

27.2 The Sub-Committee noted the following 184 signature petition presented by Councillor Tonks to council on 7 December 2007.

"We, the undersigned call upon the Council to increase the opening hours throughout the Library Service, including Sundays, as befits life in a twenty-first century metropolis."

The Chair responded that there have been some increases in opening hours in recent years with two extra afternoons a week in Jubilee Library, and an extra half day in Moulsecroomb, with small increases in Hangleton, Portslade and Mile Oak libraries achieved through efficiencies. These improvements have resulted in an increase in library user satisfaction with opening hours of 11.5%. The Chair advised that, should Labour be heading the administration post the May council elections, it was the intention to respond to public demand by introducing Sunday opening at the Jubilee Library. Councillor Mrs Theobald stated that the Conservative party would also introduce this.

27.3 **RESOLVED** – That the petitions and the responses by Councillor John be noted.

28 LIBRARIES CONSULTATION

28.1 The Sub-Committee considered a report of the Director of Cultural Services concerning the results of recent consultation (see minute book). The report highlighted the main findings of two public library user surveys which are set by the Chartered Institute of Public Finance and Accountancy (CIPFA). These are: the CIPFA Public Library User Survey (CIPFA PLUS), and the CIPFA Electronic Public Library User Survey (CIPFA ePLUS). The report also covered the results of some more in depth research into the library needs of black and minority ethnic (BME) communities in the city.

28.2 Members stated that they would like social equity indicators and stock quality assessment data to be provided to a future meeting. It was also requested that a breakdown of expenditure and income be circulated to members. Councillor Older asked to inspect the suggestions made by the public for improving the service.

30 BRIGHTON AND HOVE ARTS COMMISSION

30.1 The Sub-Committee considered a report of the Director of Cultural Services updating members on the activities of the Arts Commission of Brighton & Hove in particular the final report on the Urban Cultural Programme (see minute book). Jackie Lythell, Chair, and Julien Boast, Vice Chair, made a presentation on the work of the Arts Commission.

30.2 Mrs Lythell and Councillor Edmond Smith (Convenor of the Sustainability Commission) agreed that the Arts Commission should work with the Sustainability Commission to further the Eco-Brighton arts programme, which raises awareness of environmental issues and provides opportunities for artists to engage in ecological debate.

council as part of the Local Development Framework (see minute book).
