DETAILS OF ANY ALTERNATIVE OPTIONS

The alternative to producing a planning brief would have been to "do nothing" (i.e. not to have produced a planning brief). Following consultation with key members and local ward councillors this option was not considered acceptable as there would have remained a lack of clarity on what the local planning authority is likely to consider an acceptable development on this important and sensitive site. The site has previously been the subject of two refused planning applications from Hyde Martlet (the current owners of the site) and two appeals. Both appeals were dismissed by the Planning Inspectorate, principally on design grounds. Consequently, the planning brief provides detailed design guidance on the type and quantum of development is likely to be acceptable in design terms and that can be successfully accommodated on the site.
