1. SUMMARY AND POLICY CONTEXT:

- 1.1 The scrutiny panel on street access issues was established following concern that the accessibility of public highways within the city was being reduced.
- 1.2 The panel's report of findings and recommendations are presented here for approval by the Overview and Scrutiny Commission.

3. BACKGROUND INFORMATION

3.1 The Street Access scrutiny panel was set up following a letter to the Chief Executive from Councillors Paul Elgood and David Watkins in February 2009.

- 3.2 Having received a detailed officer report, the 21 April 2009 OSC then agreed to establish a panel to consider objects placed on the highway including site visits and to hear a wide range of views and submissions to inform future policy for the city.
- 3.3 The panel comprised Councillor Sven Rufus (Chair) and Councillors Jayne Bennett, Pat Hawkes, Councillor Brian Pidgeon and David Watkins.
- 3.4 The Members focused on traders' items especially advertising boards (A boards), tables and chairs, bicycles and bins receiving evidence from business representatives, disability charities, local resident groups and private residents.
- 3.5 The panel developed 16 recommendations to improve accessibility around the city.
