Application BH2009/03107, 1 Addison Road, Hove – Appeal against refusal to grant planning permission for the erection of one 2 no. bedroom and one 3 no. bedroom, two storey houses incorporating rooflights. **APPEAL ALLOWED** (delegated).

B. WITHDEAN

Application BH2010/02125, 8 Colebrook Road, Brighton – Appeal against refusal to grant planning permission for demolition of part of the existing ground floor to form a kitchen extension with the existing roof extended over with enhanced dormer provision. The existing dormers to be retained and re-clad in painted horizontal timber boarding. **APPEAL DISMISSED** (delegated).

C. GOLDSMID

Application BH2010/01131, 9 Brecon Court, Hove – Appeal against refusal to grant planning permission for the replacement of existing timber windows with double glazed uPVC windows. **APPEAL ALLOWED** (delegated).

D. CENTRAL HOVE

Application BH2009/01793, 11 Albert Mews, Hove – Appeal against grant of planning permission subject to conditions regarding external alterations to form new door, stairs and gateway access from basement workshop to footpath. **APPEAL DISMISSED** (committee).

Application BH2010/01622, 17 Cobton Road, Brighton – Appeal against grant of planning permission subject to conditions regarding recovering of existing roof and raising of ridge height by 400mm. **APPEAL ALLOWED** (delegated).

Application BH2010/00972, 20 Olive Road, Hove – Appeal against refusal to grant planning permission for three new houses to replace redundant and dilapidated D1 accommodation. **APPEAL DISMISSED** (delegated).

H. PRESTON PARK

Application BH2010/01652, 33 Chester Terrace, Brighton – Appeal against refusal to grant outline planning permission for single storey extension to the side elevation at the rear of the property; loft conversion - including, at the rear of the property, a single window dormer and second roof alteration to accommodate head room for new internal staircase; restore traditional timber sliding sash windows throughout (excluding roof lights and bi-folding patio doors) to replace current UPVC replacement windows; remove the current concrete interlocking roofing materials and restore the original grey slate tiles throughout (including the new extension) allowing for the inclusion of grey solar slates to rear "lean to" roof. **APPEAL DISMISSED** (delegated).

Application BH2010/01398, 35 Medina Villas, Hove – Appeal against refusal to grant Conservation Area Consent for demolition of removal of section of front wall (Appeal A). **NO FURTHER ACTION**.

Application BH2010/01286, 35 Medina Villas, Hove – Appeal against refusal to grant planning permission to demolish part of the existing front boundary wall and railing to form a new vehicular opening with piers and gates to No 35 (Appeal B). **APPEAL DISMISSED** (delegated).

Application BH2009/01713, 114 Church Street, Brighton – Appeal against refusal to grant planning permission for roof extension to the existing property to create a self contained one bedroom flat creating a live-work unit for the owner of the property. **APPEAL DISMISSED** (delegated).
