Paul Westbrook, Bursar Steve Marshall-Taylor, Deputy Head (Pupils and Pupil Welfare) Roger Nicholson, Director of Sport Fred Hammond, Jubilee Ground Head Groundsman	Brighton College, Eastern Road, Brighton	Object	<p>We are writing on behalf of Brighton College, a school whose main campus, Prep School and Pre-Prep School and Nursery are on Eastern Road, Brighton (main campus BN2 0AL) and which teaches over 1,000 children from Brighton and Hove and over 1,300 children of ages 3-18 from BN postcodes. Of these children, the College provides financial support to about 400 local boys and girls to enable them to attend the school, some of whom attend for free. The school educates a broad spectrum of children from our city.</p> <p>We are also writing further to discussions we have had about the proposal contained in the above TRO with various Council representatives organised through Rob Dumbrill, Parks Projects Manager (phone number 01273 293007) and a colleague of his who opines on road related concerns, both of whom considered our requests pragmatically and thoroughly in correspondence and in meetings including one on site at East Brighton Park. The consensus view is that our proposal to amend the TRO as detailed below should be workable.</p> <p>The TRO aims to restrict the volume of parking at East Brighton Park. This is something the College welcomes. Parking has become difficult and can hinder access for the coaches used by the College to transport children to and from the Park. However, as drafted and without modification, the TRO will hinder the efficient operations of the College using the park and impact adversely on over 1,300 children from the area. We therefore suggest a modification to the TRO which should be able to be implemented safely and without major impact on the overall intention of the TRO and which merely enshrines</p>	<p>BHCC have been working closely with the College to limit the impact of the TRO on the use of the facilities which they lease from BHCC.</p> <p>Freedom Leisure now facilitates entry for minibuses to enter the car park adjacent to the multi court facilities on Wilson Avenue to prevent the need for the college to park on the verge.</p> <p>Informal arrangements are also in place for the college to park or turn their coaches in the Whitehawk football Club ground.</p> <p>Officers met up with the college and outlined coaches will be able to park on the double yellow lines near their sports playing field as long as they parked safely on a section that didn't cause an obstruction. However, this would have to be an informal arrangement rather than a permit system and /or contained as an exception legally within the TRO. Any parking by coaches on double yellow lines would need to be</p>

		<p>some of what currently happens at the Park (the element which is not causing the problems with congestion, access and parking for valid Park users).</p> <p>Intentions of the TRO We note two of the intentions of the TRO are (paraphrasing): to improve the safety of children; and ensure the proper use of the park by genuine park users. Children and staff of the College are valid users of East Brighton Park and their safety is of paramount importance to the College.</p> <p>Valid users The College has a long lease from the Council over an area we call “The Jubilee Ground” (an area of the site containing the words “Sports Ground” three times and “Blackrock Valley” on East Brighton Park Parking Plan Schedule 1 accompanying the TRO. This area is to the east side of and adjacent to the primary road running north-east/south-west through the Park and adjacent to and north of the site containing the words Pavilion and Cricket Ground and Blackrock Valley and south of the area containing the words Football Ground all as named on the Schedule). The Jubilee Ground is home to the College’s main sports facilities (five rugby or football pitches or two cricket fields dependent on the season plus hard standing netball courts) and is regularly used throughout the term time by over 1,300 children primarily from age 7 upwards.</p> <p>Safety of children and staff Brighton College children from age 7-18 (and sometimes from 3-18) travel to the Jubilee Ground from the school campuses in coaches, which wait adjacent to the ground on areas designated as “no waiting at any time” on Schedule 1 to the TRO between the times when the children reach the park and the time they leave the park.</p> <p>Use of coaches The decision was taken by the College’s governing body that children should be conveyed on coaches between the schools’ campuses and the Jubilee Ground following the death of a child at Worth School recently. had been killed while crossing a road to access Worth's sports grounds and the College felt it did not want to take the risk of the same event occurring with a pupil in Brighton. The route between the College's campuses and the Jubilee Ground contains many crossing of roads and drives including those to the hospital. The road is an ambulance route and has a fire station on it which means vehicles can sometimes travel very quickly. The last part of the route is adjacent to areas of the park outside of the Jubilee Ground which are sometimes home to the travelling community and other users, some of whom have historically found it amusing to intimidate the children either vocally, with abusive gestures and occasionally with missiles. As a result, the College now conveys children to the Jubilee Ground by coach.

Parking adjacent to Ground

When children are at the ground and it rains, the College likes the children to be able to access the coaches quickly from the Jubilee Ground. Apart from general concerns over catching chills and so on, in thunderstorms, we do not like children to be at risk from lightning strikes.

The timetable is very tight at the College and can be flexed meaning that certain children may not be using the ground for the same length of time as others and the ability to have coaches on standby to enable such flexibility is useful and helps maximise the time available for sport. The College timetable is very tight/efficient and any delay in a coach reaching the park as a result of having to wait elsewhere will have a knock on impact on dining, academic lessons or other co-curricular activities and also prevent the subsequent coachload of children reaching the park on time.

One of central and local government aims is to encourage the general health and physical well-being of the nation. Brighton College has a significant part of its timetable given over to sport and healthy activity and wishes to maximise the use of the time set aside for such

activity. As a result, ensuring the stay at the ground is maximised is also important.

As a result, of all of the above, the College has to date ensured that coaches in which children have travelled park adjacent to the ground and wait (there is no on site parking for coaches – there is insufficient room and the topology of the land prevents it).

Other considerations

Brighton College has become high profile over the last few years having won two school of the year awards in three years and its success has reflected well on Brighton generally. High profile and very popular education conferences take place annually with the current secretary of state for education having spoken at these over the last few years alongside other high profile individuals including Jeremy Paxman, the historian David Starkey etc. Brighton College has also been named the Royal Institute of British Architecture Client of the Year twice in the last three years for its developing campus plan (and will play host to the City’s Heritage Society, Regency Society etc in the early part of next year, having already hosted the Council’s own event to launch its vision for the future two years ago). These successes have reflected well on Brighton itself and the College has been proud to illustrate how helpful the Council has been in enabling the College to meet tight planning timetables etc. In short, the Council and the College are forging strong links with each taking full account of the operational needs of the other. I very much hope this request will see a continuation of this incredibly helpful approach for which the College has been very grateful. I have chosen not to alert the local College parents to the TRO as we feel you would be inundated unhelpfully. However, this submission’s request for a modification is likely to reflect the views of a significant number of local residents in Brighton and Hove.

Proposed modification to TRO

The College (having spoken with the Parks Project Manager and other Council representatives) has been led

to believe it can continue with its current regime whereby coaches both transport children to and from the Jubilee Ground and also park and wait alongside the road. As a result, the College wishes the TRO to make specific provision for the ability for coaches taking children of Brighton College and teams that are playing against (or in tournaments involving) Brighton College to park and wait while their passengers are using the Jubilee Ground. On week days during term times, there are six coaches conveying children to and from the Jubilee Ground that we would wish to be able to park close to the ground on areas currently designated as no waiting on Schedule 1 and on Saturdays, there would be a total of two coaches (which will have conveyed visiting teams). The use is throughout the whole day for all six of these days during term time.

The coaches would have the drivers in them throughout (other than for any comfort breaks), would park sensibly on stretches of the road where there is adequate width for vehicles to pass safely and would be able to move if ever there were an obstruction caused.

Request for modification to TRO

The College therefore wishes to amend the TRO and insert a new clause in the TRO to enable the above coaches to park in the area. Provided it does actually achieve the aim outlined in the remainder of this email, it seems this might most easily be effected by including in "Part 2 – Waiting of Vehicles" clause 2 a new sub clause (10) so that "nothing in Article 1 of this Part shall prevent any person from using causing or permitting a vehicle to park, stop or wait in a Restricted Road during the Prescribed Hours; (10) if the vehicle is a coach whose most recent passengers are using the Jubilee Ground (such area to be defined on Schedule 1 or as I have defined its location above) either in their capacity as pupils or staff of Brighton College or in their capacity as a team playing against or in a tournament with Brighton College."

If it would help to have badges issued for the coaches so it is clear it is a coach that is waiting there in that capacity, we would need to have a store of such badges

			<p>as we use a variety of coaches.</p> <p>Reason why we feel the Council should accept the request</p> <p>Having spoken with the Council representatives who have been to the site and considered the College's requests, there is adequate parking room on the "no waiting at any time" stretches of road in the areas along the road adjacent to the Jubilee Ground to facilitate this and the coaches would be manned and therefore able to move swiftly in the unlikely event they were causing an obstruction.</p> <p>As this regime is currently in operation and it has never been the College coaches that have caused any obstructions (or not without immediate movement to alleviate any obstruction), we do not think the solution we propose will compromise the intention within the TRO. We look forward to confirmation that this request is acceptable in line with initial indications from the Parks team and that the College can continue to use its own sports facilities without hindrance; to maximise the time available to the boys and girls for sport; to enable them to access and leave the ground safely; to have somewhere immediate to go in the event of poor and potentially dangerous weather; and to provide flexibility to ensure the remainder of the school curriculum can be accommodated by the proximate parking and waiting of coaches to the ground.</p>

I am in a local cricket team which hires the cricket pitch from the council (cost of £80) on many Sundays during the summer. Several members of the team have to drive to the park as we give lifts to other members of the team as well as bring all of the required kit. It would be unfair for us to have to pay additional charges in addition to the £80 we already pay to hire the cricket pitch. Additionally, it's not suitable for us to use public transport due to having to bring a lot of equipment to the park in order to play. I wish to draw to your attention a report that I submitted during the consultation process which looks to have been completely ignored. I wish to object to the proposed restrictions because this will affect the members of the publics use of the park, in particular with the council run scheme of Healthwalks. These walks are designed to help Brighton residents to get fit, remain fit and also to provide a social element to walking thus improving their health and wellbeing. The scheme is supported by the NHS and has had immense successes. If these proposals occur as outlined in the plan I believe people will be driven away from this very popular walk due in part to its location to the east of the City. I therefore wish you to be made aware of my report and to consider the points I have made.	The alternative proposals put forward in this response (restricting maximum length of stay to 4 hours and/or giving certain groups exemption stickers or vouchers are not the preferred options. The scheme has to be self-financing and these proposals would be resource intensive in terms of administration and enforcement. Proposed charges have been kept at significantly lower levels than on street parking to minimise the impact on genuine park users. The

Proposed control parking East Brighton Park

I have read the proposals and the reasons for them.

The problem in East Brighton park are due in the main with 'travellers' vehicles that are parked on the southern side of the parks access road but there is also indiscriminate parking at the park entrance adjacent to Wilson Avenue.

What is proposed is over complicated and unnecessary and does require a little more fore thought and planning.

The 'travellers' vehicles/private caravans can easily be displaced by purely placing a time restriction on parking along the access road and the other designated parking areas in the vicinity of the Pavilion cafe. The double yellow lines indicated on the plan would prevent parking where the road is narrow and this has obvious benefits to park users.

A realistic time of four hours maximum parking with no return for four hours would suffice. This would mean that persons using the park legitimately would not be inconvenienced by parking charges but would still have ample time to visit the park or cafe, play sports, socialise or walk.

The entrance area, quite rightly, requires marked bays and could be subject of a parking charge but equally could also be subject of restricted parking as I mention earlier, thus preventing inconvenience to other traffic.

Parking on the verges along Wilson Avenue would be remedied by the proposal of double yellow lines on the east side of this road. This in effect prevents parking on that side of the highway, the grass verge being a part of

times at which charges apply have also been limited.

the highway.

I do not understand the logic of a single yellow line on the west side of Wilson Avenue. As can be seen this side of the road is habitually used for parking and any change to this seems unnecessary.

In essence these proposals are too draconian and actually take away the public's free access to the park. I note that mention is made that the charges would be used to implement the scheme but surely this can be funded centrally taking into account the vast revenues received by the council from parking within the city.

There is another consideration that has been either ignored or overlooked and I wish to make you aware of this. I am bringing this to your attention because the Sports Development Team of Brighton and Hove City Council were not approached or consulted on these proposals.

Healthwalks is a scheme that began over 10 years ago, (please visit the Healthwalks page on the council's website for further information on this scheme). The scheme provides assistance both physical and mentally to local people. These walks are free to attend and are led by qualified volunteer leaders. When these proposals were advertised the Sheepcote walkers were somewhat shocked.

As a result I conducted a poll and 96% stated they would no longer attend this walk if parking charges were introduced. This walk is extremely popular with an average attendance of about 20 people. Even more worrying is the fact that some walkers stated this is the only walk they were likely to attend and would give up walking. The walkers do feel very let down by the council
