In 2015/16 the school will have 60 children in Reception and Years 1-5 inclusive. In 2016/17 the school will

have 60 children in all year groups, i.e. Reception and Years 1-6 inclusive. It is proposed that places in Year 3 in 2013/14 and 2014/15 will be allocated in accordance with the Local Authority's published admission arrangements.

In accordance with section 19(1) of the Education and Inspections Act 2006 Brighton & Hove City Council intends to make a prescribed alteration to Portslade Community Infant School Locks Hill, Portslade, Brighton, BN41 2LA from 2nd

September 2013.

Brighton & Hove City Council proposes changing the age range of the school by a year or more. It is proposed that Portslade Infant School is made in to a two form entry all through primary school from September 2013. The new school will have an intake of 60 pupils at 4+. Flexibility would be provided for Key Stage 2 to take additional children to a maximum of 32 children per class.

School capacity

10. The objectives of the proposals.

Over the last few years there has been year on year growth in the number of preschool age children registered with General Practice (GP) Surgeries in the city. This increase is occurring to some extent right across the city but is particularly acute in central Hove and to the west of the city, which is served by the schools in Portslade.

It is recognised that not all of these children will enter the maintained education sector, some will opt to attend private schools or be home educated, it is also recognised that parents of pre school age children tend to be most geographically mobile in the first four years of a childs life. However even taking these figures into account the increase in the number of pre school age children in this part of the city is significant.

The Council has a statutory duty to provide a maintained school place for any child that wants one. We are committed to working with schools, their governing bodies and the diocese to make them centres for community learning, and supporting them in meeting the wider needs of the community by engaging social services, health, the police, and the voluntary sector. For this to be successful it is important that children can access a primary school that is local to their home.

To this end in September 2011 the Council made a permanent change to the age range of Benfield Junior School so that it became an all through primary school. In so doing a need was created for an additional three forms of entry for Juniors in the Portslade areas. This proposal will go some way to meeting that need.

Changing the age range of Portslade Infant school in this way will enable local parents wishing to send their children to a local primary school to do just that. This means that children will be able to attend school with friends that they have made prior to starting school, parents will not have to travel long distances to deliver their children to school and extended services offered by the schools can be tailored to meet the needs of the whole community.

Extended services

This proposal will result pupils staying at the same school for the entirety of their primary education. The resultant enlargement of the premises will ensure that the impact on the community and any use they may make of the school for extended activities or any other purposes will not affected by this proposal. It is not anticipated that there will be any negative impact on the extended services offered by the schools as a result of this proposal.

The GP registration data for Brighton & Hove shows that pupil numbers in the city are rising and that additional school places are required to ensure the statutory obligation of providing a school place for every child that wants one is met. The number of children approaching school age registered with GP's had been rising and the trend indicates that the numbers of pupils wishing to obtain a place in a maintained school will continue at the higher levels for the foreseeable future.

The Section 21 return that LA's are required to make each year records surplus capacity in the primary and secondary sectors. From our 2011 return we are recorded as having 1,849 surplus places in the primary sector which equates to 10%. However this is not actually a true picture of the situation as the return does not take into account those schools that are over capacity. If the surplus capacity is calculated based on the total number of pupils in school in the city the percentage of surplus places is reduced to 8.0%.

Reception cohorts within the city as a whole are growing year on year but until the smaller cohorts currently in years 5 and 6 means the surplus places return will still show a significant surplus for certain schools in parts of the city. This distortion of the figures is worsened by the fact that schools who admit above their net capacity are omitted from the calculation as are schools who may admit additional pupils at Key Stage 2. It is entirely possible and allowable for schools to admit above their net capacity in Key Stage 2 and this is what a number of schools in the city have done to try to accommodate pupils in their local area. The situation is also adversely affected by the fact that where there is some surplus accommodation in the City, it is not where the school age population is currently growing in the centre of the City, but on the periphery. Parental expectation at primary level is of a local place, not a three or four mile bus journey each day.

This proposal regarding the change of age range for Portslade Infant School will provide additional primary places within the city for children aged 7 to 11. This is considered as necessary to assist with managing the year on year growth outlined above. It is not anticipated that there will be any significant knock on effect to other schools in the locality.
